SECOND AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR WALDEN POND

This Second Amendment to Declaration of Covenants, Conditions and Restrictions for Walden Pond (this "Amendment") is made by MM WALDEN POND, LLC, a Texas limited liability company ("Declarant"), and is as follows:

RECITALS:

- A. Declarant is the "Declarant" under that certain <u>Declaration of Covenants, Conditions and Restrictions for Walden Pond</u>, recorded under Document No. 2023-0004883, in the Official Public Records of Kaufman County, Texas, as amended by that certain <u>First Amendment to Declaration of Covenants, Conditions and Restrictions for Walden Pond</u>, recorded under Document No. 2023-0017246, in the Official Public Records of Kaufman County, Texas (collectively, the "**Declaration**").
- **B.** Section B.3.4 of <u>Appendix "B"</u> to the Declaration provides that the Declaration may be amended unilaterally by the Declarant during the Development Period for the purpose of complying with the requirements of an underwriting lender.
- C. The Development Period is defined in Section 1.15 of the Declaration as the period of time beginning on the date the Declaration is recorded in the real property records of Kaufman County, Texas, and ending on the earlier of (i) fifty (50) years after the date the Declaration was recorded, or (ii) the date on which the Declarant records a written notice of termination of the Development Period in the real property records of Kaufman County, Texas. The Declaration was recorded in the Official Public Records of Kaufman County, Texas, on February 27, 2023, and the Declarant has not recorded a termination of Development Period. Accordingly, the Development Period is still in effect.
 - **D.** Declarant desires to amend the Declaration as set forth hereinbelow.

NOW THEREFORE, Declarant hereby amends and modifies the Declaration as follows:

- 1. FHA, VA and USDA Requirements. The following provision is hereby added to *Article 17* of the Declaration as *Section 17.11*:
 - 17.11 FHA, VA and USDA Requirements. Notwithstanding any inconsistent or contrary provision in this Declaration, if there are any FHA, VA, or USDA insured loans affecting a Lot, and only for so long as any such loans affect the Lot, any restrictions in this Declaration regarding renting, subleasing, or reconveyance that violate any FHA, VA or USDA requirements will not apply to such Lot or its Owner.

2. <u>Miscellaneous</u>. Any capitalized terms used and not otherwise defined herein shall have the meanings set forth in the Declaration. Unless expressly amended by this Amendment, all other terms and provisions of the Declaration remain in full force and effect as written, and are hereby ratified and confirmed.
